**100 days Campaign - “Saksham Niveshak”: 28th July 2025 to 6th November 2025 Update Your
KYC Details and Claim Your Unpaid/Unclaimed Dividends**

The Investor’s Education and Protection Fund Authority [“IEPFA”], Ministry of Corporate Affairs [“MCA”] vide its circular dated 16th July 2025 has launched a ‘100 days’ campaign – “Saksham Niveshak” effective from 28th July 2025 till 6th November 2025, targeting all shareholders whose dividends have remained unpaid/unclaimed. The Company is accordingly launching this Campaign to enable shareholders to claim unpaid / unclaimed dividend.

- Purpose of the campaign: To create awareness among shareholders to update their KYC details and claim any unpaid or unclaimed dividends before they get transferred to the Investor Education and Protection Fund (“IEPF”).
- Benefit to shareholders: Pursuant to applicable SEBI circulars, for credit of dividends directly to their bank accounts (since dividends are payable only in electronic mode), it is important to update PAN, nomination details, contact information (postal address, mobile number), bank account details, specimen signature with the Company or the Registrar & Transfer Agent: KFin Technologies Limited.

Information / documents to be submitted:

- Form ISR-1: Duly filled and signed, with self-attested KYC documents.
- Form ISR-2: Duly filled and signed, with banker’s attestation of your signature and original Cancelled Cheque (with your name printed) or self-attested bank passbook / statement.
- Form SH-13: For adding a nominee.
- Form ISR-3: If you wish to opt out of nomination.
